What is the purpose of this update?

This document tells you how the Kōura Wealth KiwiSaver Scheme Conservative Strategy has performed and what fees were charged. The document will help you to compare the fund with other funds. Kōura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Conservative Strategy aims to replicate the equivalent of 25% growth and 75% income assets by investing in Koura Funds. Our Conservative Strategy primarily focuses on safeguarding your money while aiming for modest capital growth.

What are the risks of investing?

Risk indicator for the Conservative Strategy¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. 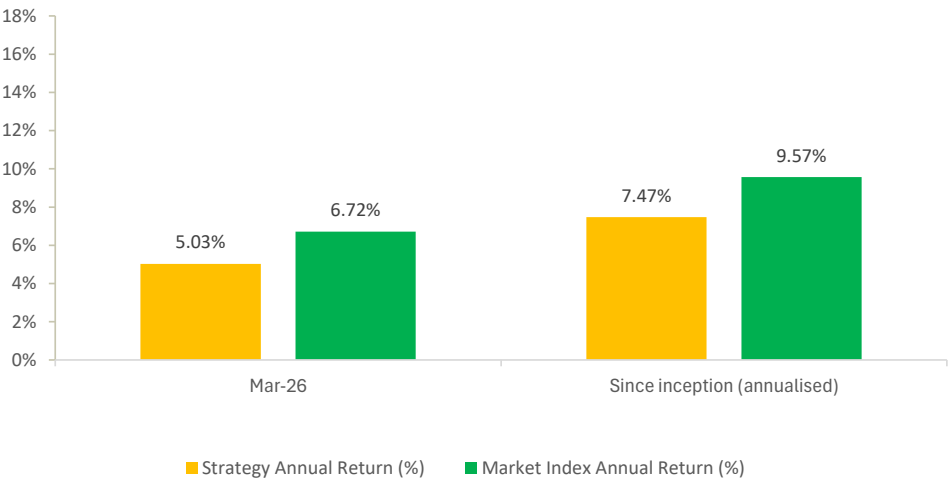

How has the fund performed?

The market index return is made up of 19% in the Bloomberg NZ Bond Bank Bill index return, 56.3% in the Bloomberg NZ Bond Composite 0+Y index return, 3.9% in the Morningstar New Zealand Gross Return index return and 20.8% in the Morningstar Global Markets (50% translated to NZD) index return.

Annual return graph²



This shows the return after fund charges and tax for each year ending 31 March since the strategy started. The last bar shows the return since the strategy started, up to 30 June 2026 on an annualised basis.

Important: This does not tell you how the strategy will perform in the future. Returns in this update are after tax at the highest prescribed investor rate (PIR) 28% tax for an individual New Zealand resident. Your tax may be lower. The market index return reflects no deduction for charges and tax.

What fees are investors charged?

Example of how this applies to an investor:

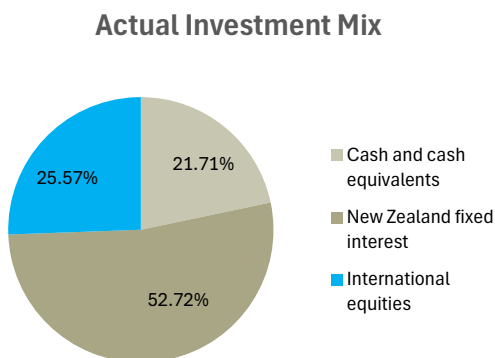
Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the beginning of the year and did not make any further contributions. At the end of the period, Lily received a return after fund charges were deducted of \$850. (That is 8.50% of her initial \$10,000). Lily also paid \$30 in administration charges. This gives Lily a total return after tax and charges of \$820 for the period.

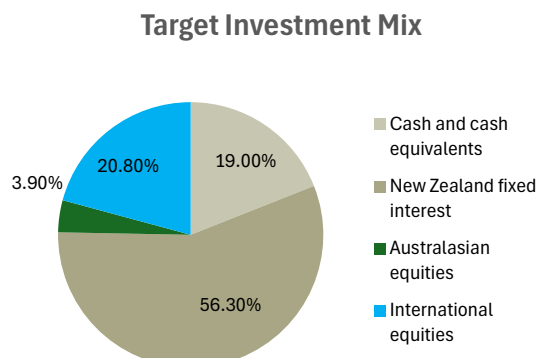
What does the fund invest in?

The fund's exposure to assets denominated in foreign currencies was 25.57%, of which 0% was hedged. This means the fund's unhedged foreign currency exposure was 25.57% of the net asset value of the fund.

Notes

1. As the strategies started on 15 April 2024, underlying fund returns have been used from 1 July 2021.
2. The bar chart show fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted. Since inception returns are calculated from the first full calendar month following the strategy's launch.
