What is the purpose of this update?

This document tells you how the Kōura Wealth KiwiSaver Scheme Growth Strategy has performed and what fees were charged. The document will help you to compare the fund with other funds. Kōura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Growth Strategy aims to replicate the equivalent of 80% growth and 20% income assets by investing in Koura Funds. Our Growth Strategy targets higher-risk and higher-return opportunities, primarily through investments in shares with an allocation to fixed interest assets providing some risk mitigation.

What are the risks of investing?

Risk indicator for the Growth Strategy¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. 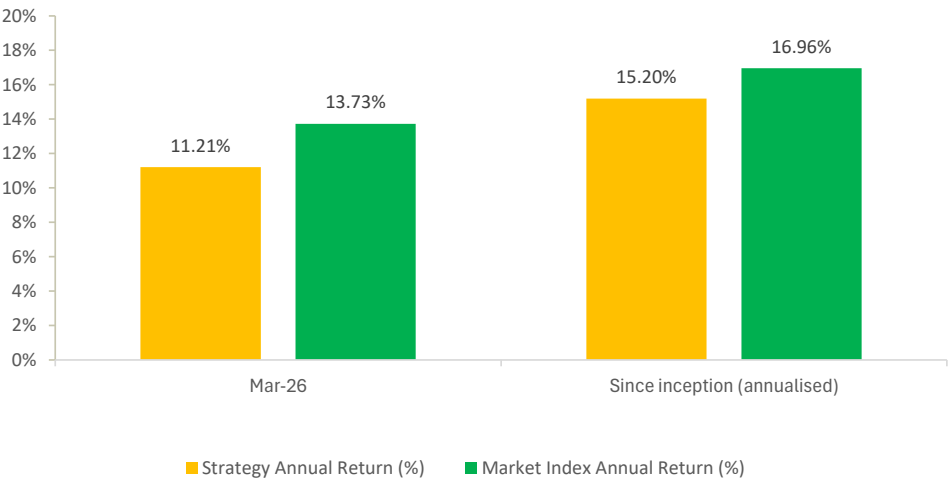

How has the fund performed?

The market index return is made up of 20.2% in the Bloomberg NZ Bond Composite 0+Y index return, 12.6% in the Morningstar New Zealand Gross Return index return and 67.2% in the Morningstar Global Markets (50% translated to NZD) index return.

Annual return graph²



This shows the return after fund charges and tax for each year ending 31 March since the strategy started. The last bar shows the return since the strategy started, up to 30 June 2026 on an annualised basis.

Important: This does not tell you how the strategy will perform in the future. Returns in this update are after tax at the highest prescribed investor rate (PIR) 28% tax for an individual New Zealand resident. Your tax may be lower. The market index return reflects no deduction for charges and tax.

What fees are investors charged?

Example of how this applies to an investor:

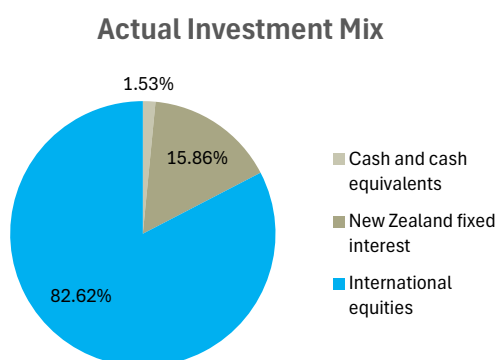
Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the beginning of the year and did not make any further contributions. At the end of the period, Lily received a return after fund charges were deducted of \$2157. (That is 21.57% of her initial \$10,000). Lily also paid \$30 in administration charges. This gives Lily a total return after tax and charges of \$2127 for the period.

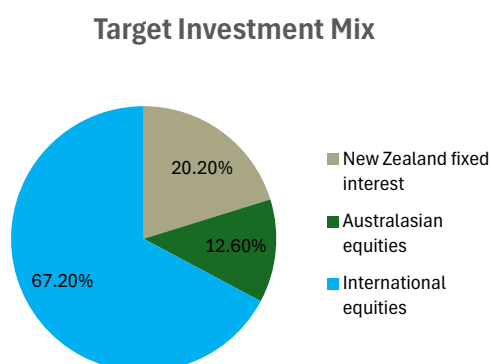
What does the fund invest in?

The fund's exposure to assets denominated in foreign currencies was 82.62%, of which 0% was hedged. This means the fund's unhedged foreign currency exposure was 82.62% of the net asset value of the fund.
