What is the purpose of this update?

This document tells you how the Kōura Wealth KiwiSaver Scheme Strategic High Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Kōura Wealth Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund invests in a range of assets to take advantage of both global and domestic investment opportunities. Its asset allocation is similar to a traditional aggressive fund.

What are the risks of investing?

Risk indicator for the Strategic High Growth Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. 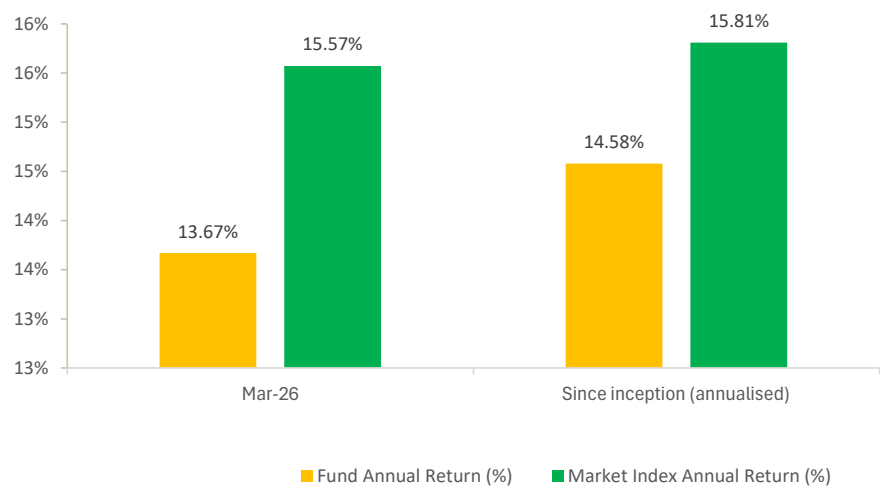

How has the fund performed?

The market index return is made up of 5% in the Bloomberg NZ Bond Composite 0+Y index return, 15% in the Morningstar New Zealand Gross Return index return, 80% in the Morningstar Global Markets Index return (50% translated to NZD). The market index return reflects no deduction for charges and tax.

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the return since the fund started, up to 30 June 2026 on an annualised basis.

What fees are investors charged?

Example of how this applies to an investor:

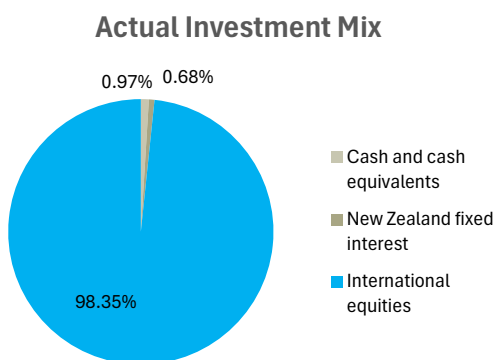
Small differences in fees and charges can have a big impact on your investment over the long term.

Lily had \$10,000 in the fund at the beginning of the year and did not make any further contributions. At the end of the period, Lily received a return after fund charges were deducted of \$2510. (That is 25.10% of her initial \$10,000). Lily also paid \$30 in administration charges. This gives Lily a total return after tax and charges of \$2480 for the period.

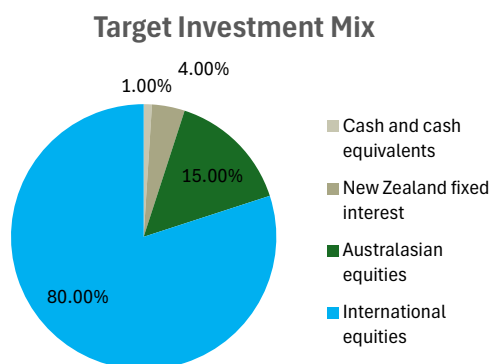
What does the fund invest in?

The fund's exposure to assets denominated in foreign currencies was 98.38%, of which 0% was hedged. This means the fund's unhedged foreign currency exposure was 98.38% of the net asset value of the fund.

Notes

1. As the fund started on 9 December 2024, actual returns for the fund are not available until then. To calculate the risk indicator for the five-year period ending 30 June 2026, market index returns have been used up to 9 December 2024 with actual fund returns used for the balance of the period. As a result of those market returns, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund.
2. Performance has been calculated from 9 December 2024, when the first investment was made in the fund.
3. The bar chart show fund returns after the deduction of fees and taxes, however, the market index returns are shown before any fees or taxes are deducted.
